## NOTICE TO VETERANS WHO SERVED AT FORT MCCLELLAN:

# MANY VETERANS WHO SERVED AT FORT MCCLELLAN WERE EXPOSED TO HARMFUL HERBICIDE AGENTS, INCLUDING THOSE USED IN AGENT ORANGE.

If you are a veteran who served at Fort McClellan from 1969-1976, and have one of the following medical conditions, it could be related to your military service: acute and subacute peripheral neuropathy, AL Amyloidosis, Chloracne (or similar acneform disease), Leukemias, Diabetes mellitus, type II, Hodgkin's disease, Ischemic heart disease, Multiple Myeloma, Parkinson's disease, Porphyria Cutanea Tarda, Prostate Cancer, Kidney cancer, Liver cancer, Bladder cancer, Non-Hodgkin's Lymphoma, Respiratory Cancers, Soft Tissue Sarcoma, Aplastic Anemia or other Myelodysplastic

syndromes, Immune-related diseases, and Neurological conditions, e.g. Multiple Sclerosis.

If you have one of these conditions and you served at Fort McClellan between 1969 and 1976, it could be due to exposures during service. This could mean that you are entitled to substantial VA benefits.
